




WHAT IS AN eCITATION?

Electronic citations allow law enforcement officers to print legible tickets on the spot while automatically transmitting digital information about the incident to municipal, police, and court records management systems.

HOW eCITATION WORKS



INCREASE OFFICER SAFETY BY REDUCING DANGEROUS ROADSIDE TIME

Traffic-related fatalities accounted for over 36% of officer deaths in the first half of 2018. Of those traffic-related fatalities, over 25% were due to roadside deaths.¹ eCitation systems can **reduce ticketing time by more than 50%**.²

REDUCE TICKETING TIME BY:





PROVIDE GREATER CITATION ACCURACY AND TRANSPARENCY IN THE CITATION PROCESS

10-15% of handwritten tickets are dismissed due to illegibility (that's **\$600-900 million in lost revenue!**)³

Neat, legible eCitations = 98% citation accuracy⁴



DRIVE BETTER EFFICIENCY THROUGHOUT THE DEPARTMENT WITH A SYSTEM-WIDE APPROACH

Ticket **processing time goes from 12 days to mere seconds** with eCitations.⁵ Nearly instantaneous access to traffic violations and accident data.

Single point of data entry = no manual entry, fewer errors, less rework.



IMPROVE OFFICER PRODUCTIVITY AND JOB SATISFACTION

It takes an officer 10-15 minutes to manually issue a citation.⁶ eCitations take 2-3 minutes and eliminate up to 200 keystrokes.⁷ Officers can spend less time pushing paper and more time serving and protecting.
